- Return to the hotel and relax.
- Overnight stay at Madinah.

**Day 3: CHECK OUT – TRANSFER TO MAKKAH – CHECK IN MAKKAH**

- We will proceed to check out from the hotel after Zohar prayers.
- After check out, transfer to Makkah on the way stop for Miqat.
- Proceed to the Makkah hotel to move towards Masjid E Haram to perform Umrah.
- Overnight at Makkah.

**Day 4: DAY AT LEISURE – MAKKAH**

- If you wish to do 2nd Umrah you will have to take a cab on your own and go to Masjid Aysha which is the Miqat and get into Ihram.
- Then come back to Haram And Perform Umrah again.
- Overnight at Makkah.

**Day 5: DAY AT LEISURE – MAKKAH**

- You have the day at leisure you can spend at Haram.
- Then come back to the hotel and relax.
- Overnight at Makkah.

### **Day 6: DEPARTURE**

- Today, get ready for your homebound flight.
- Check out from the hotel and transfer to the airport.
- Departure.
